## Five-Point Road Map of the State Administration Council

1. The Union Election Commission will be reconstituted and its mandated tasks, including the scrutiny of voter lists, shall be implemented in accordance with the law.
2. Effective measures will be taken with added momentum to prevent and manage the COVID-19 pandemic.
3. Actions will be taken to ensure the speedy recovery of businesses from the impact of COVID-19.
4. Emphasis will be placed on achieving enduring peace for the entire nation in line with the agreements set out in the Nationwide Ceasefire Agreement.
5. Upon accomplishing the provisions of the state of emergency, free and fair multiparty democratic elections will be held in line with the 2008 Constitution, and further work will be undertaken to hand over State duties to the winning party in accordance with democratic standards.

## Monsoon paddy plantation in Sagaing region results in abundant harvests

THE monsoon paddy, which has been cultivated to produce 100 baskets of monsoon paddy per acre in the five-year project, has been harvested abundantly in the Sagaing region, said U Aung Kyi Win, deputy head of the Region Agriculture Department.

“The department has cultivated 1,000 acres of model plot in Sagaing region to produce 100 baskets of monsoon paddy per acre in the five-year project. Now, the growers started harvesting and yielded about 120 or 130 baskets per acre of fresh paddy. It has yielded over 100 baskets per acre. The yield of the paddy is good due to the good weather and technical support from the department,” said the deputy head of the region department.

About 1,000 acres of the model plot were cultivated from June to September 2021 in the Sagaing region. Those are started harvesting in the first week of November. It has yielded about 130 baskets of fresh monsoon paddy and 108 baskets of dried paddy. The Agriculture Depart-

ment made the five-year project (from 2021 to 2025) to produce 100 baskets of monsoon paddy per acre.

The department grew 80 acres of paddy in Sagaing district,

120 acres in Monywa district, 70 acres in Yinmabin district, 170 acres in Shwebo district, 60 acres in Kanbalu district, 180 acres in Katha district, 100 acres in Kalay district, 110 acres in Kaw-

lin district, 30 acres in Mawlaik district, 50 acres in Tamu district and 30 acres in Hkamti district in Sagaing region.

In next 2022, the Sagaing region is planning to grow 5,000 or

10,000 acres of monsoon paddy in the next monsoon paddy plantation season. The department will provide agriculture technology to become the rest of the plots as model plots. — Lu Lay/GNLM

## Three special civil appeals given judgements; five special civil appeals heard in court

A total of three special civil appeals was given judgements, and five special civil appeals were heard at Office No. (1), Supreme Court of the Union yesterday morning.

Special appeals tribunal was led by Chief Justice of the Union U Htun Htun Oo and Judges of the Supreme Court of the Union U Myo Maung, U Kyi Thein, U Tin Hone, and Daw Khin May Yi.

A total of three special civil appeals: 4/2020 (Ayeyawady), 5/2020 (Ayeyawady), and 7/2020 (Yangon), were given judgements.

In addition, five special appeals No. 89/2019 (Mon), 96/2019 (Mandalay), 97/2019 (Mandalay), 8/2020 (Yangon), and 11/2020 (Magway) were heard as per the COVID-19 prevention measures.

## MoC conducts daily import processes for anti-COVID-19 equipment



THE Ministry of Commerce is making efforts to ensure people have access to the essential medical supplies that are critical to the COVID-19 prevention, control and treatment activities, including liquid oxygen and oxygen cylinders, by arranging continuous importation through trading

posts, international airports and seaports with the Standard Operating Procedures (SOPs).

Anti-COVID-19 products were imported by three companies using four vehicles yesterday.

A total of 20 tonnes of liquid oxygen carried by one bowser, one oxygen generator,

and 13 tonnes of masks were imported via the Myawady and Chinshwehaw trading zones, and Yangon International Seaports, officials said.

One bowser transported liquid oxygen to Yangon via the Myawady trading zone, officials added.

Officials from the relevant departments are cooperating to facilitate and expedite the Standard Operating Procedures, including online registration for the import process.

It is reported that the Ministry of Commerce is coordinating with relevant departments, treatment of COVID-19, as well as contact persons for inquiries can be reached through the Ministry's Website —www.commerce.gov.mm. — MNA

## Residents in Kengtung township screened for COVID-19, receiving vaccines

RESIDENTS in Kengtung Township were screened for COVID-19 infection with RDT Test Kits free of charge and those who were not infected with the diseases received the first dose of Sinopharm COVID-19 vaccine on 21 November.

The screening test was carried out to further reduce the incidence of the COVID-19 virus in Kengtung Township and 13 of 1,137 people had been tested positive for COVID-19, with an infection rate of 1.14 per cent. Those who were diagnosed with COVID-19 were systematically sent to the confirmed patient ward for medical treatment, and those who had tested negative and who had not received the vaccination were administered the first dose of the COVID-19

vaccines.

It is reported that the Township Administration Body, police, medics, healthcare professionals, members of the fire brigade and civil society organizations, collaborated for the free COVID-19 screening test in city checkpoints, villages, wards, Kengtung Public Hospital and fever clinics.

From 29 June up till 21 November, 5,474 COVID-19 positive patients admitted to hospitals, 5,244 people recovered, 92 deaths, and 138 confirmed patients currently under treatment in Kengtung Township. Officials have been increasing the activities for the prevention, control and treatment of COVID-19 in the township. — Aung Zin Myint (IPRD)/GNLM

## Domestic investments top K1,171 bln in FY2020-2021

INVESTMENTS by Myanmar citizens in the country stood at K1,171 billion in the financial year 2020-2021 (October-September), according to data released by the Directorate of Investment and Company Administration (DICA).

In the FY2020-2021, the domestic investors pumped K1,171 billion into 17 projects permitted by the Myanmar Investment Commission and into 44 projects endorsed by the state and region investment committees, as per the DICA's

data.

The manufacturing sector attracted the majority of domestic investments. The domestic investments also flowed into the hotels and tourism sector and other services sector, the livestock and fisheries, the real

estate development sector, the transport and communications sector, the power and agriculture sectors.

The Ministry of Investment and Foreign Economic Relations has been inviting responsible businesses to benefit the

country.

MIC ensures to approve the responsible businesses by assessing environmental and social impacts. The commission is working together with the relevant departments to screen the projects. — KK/GNLM

## Palm oil distributed at fairer prices

THE Ministry of Commerce and the Myanmar Edible Oil Dealers' Association imported the palm oil at the CBM reference rate using \$12 million and sold at K4,240 per viss in regions/states beginning 9 November.

A total of 7,070.55 tonnes (4,327,180 visses) of palm oil has

been sold in Yangon, Mandalay, Sagaing, Bago, Magway and Taninthayi regions, Shan and Mon states, and Nay Pyi Taw.

Moreover, the association will also arrange palm oil trucks in the wards of the regions and states.

The palm oil wholesalers will have to resell the oil

**549 new cases of COVID-19 reported on 22 November, total figure rises to 518,471**

MYANMAR'S COVID-19 positive cases rose to 518,471 after 549 new cases were reported on 22 November 2021 according to the Ministry of Health. Among these confirmed cases, 491,781 have been discharged from hospitals. Death toll reached 19,034 after 9 died.—MNA

## MIFER Union minister visits investment activities in Yangon

UNION Minister for Investment and Foreign Economic Relations U Aung Naing Oo visited the TYTC Services Co., Ltd, which operates a local industrial waste collection and disposal service and manufactures equipment required for this business with the permission of the Myanmar Investment Commission in Hlinethaya Township, Yangon Region, yesterday morning.

Directors of the company reported on the preparation to start work after obtaining permission from the Myanmar Investment Commission, current challenges and further investment matters. The Union minister coordinated for the immediate start of the business with relevant departments and organizations, and with the relevant Industrial Management Committee and business owners for the waste collection and disposal. He also

gave necessary suggestions on further expansion of the business.

Afterwards, the Union minister arrived at Colgate-Palmolive (Myanmar) Limited, which produces and distributes oral and personal health products in Shwepyitha Township and observed the operation of the industry. The Union Minister discussed ways to assist in increasing import substitution production, and carrying out dental and oral health awareness programmes as the company's corporate social responsibility.

In the afternoon, the Union minister arrived at SC Auto (Myanmar) Co., Ltd and the directors of the company presented the vehicle production condition, distribution to the local market and exports of manufactured buses. The Union minister discussed the programmes of the



Ministry to assist in expanding markets and vehicle exports, and further cooperation for research and development, the production and distribution of electric passenger vehicles in the domestic market and facilitation for necessary vehicle parts importation.

SC Auto is assembling and selling SC Neustar brand European standard passenger buses with the 100-per-cent foreign investment in the Yangon Industrial Zone in Mingaladon Township of the Yangon Region. The plant can produce up to 600

buses per year using the CKD system and is preparing to export 50 per cent of its output to ASEAN countries. The company is researching electric buses in Singapore and is preparing to install electric buses in Myanmar in a few years. — MNA

## MoC Union minister inspects roads, infrastructures in Yangon Region



UNION Minister for Construction U Shwe Lay visited the construction site of a five-storey extension of the Orthopaedic Hospital in Kyimyindine Township, Yangon Region on 21 November.

The Director-General and his team explained the construction works for each financial year.

On the submissions, the Union Minister praised them for the

quality and standard of hospital construction work and urged them to have timely completion of funding activities.

The Union minister instructed officials to coordinate the needs of the hospital as per the specifications.

After that, the Union minister donated K1 million to medical Superintendent Dr Ye Myint

Aung for use in the development of the hospital and inspected the construction site.

Afterwards, the Union minister and party arrived at the construction site of Dala Bridge (Yangon side) and the responsible persons explained the working conditions.

On the submissions, the Union Minister said that the companies responsible for the construction work for the timely completion of the bridge need to follow the project plan.

Coordinating with relevant organizations to ensure the smooth operation of the bridge construction work is essential during the COVID-19 period.

The Dala Bridge is important for the friendship between the two countries and will provide an opportunity for Myanmar engineers to exchange technologies.

The Union minister called for speedy completion of the construction work.

Afterwards, the Union minister and party inspected the construction of approach bridges on the Yangon and Dala sides.

Next, U Kyaw Swa Tun, Acting Director of Construction Task Force-1, Department of Bridges explained the excavation work of the 2,428-foot-long Seikkyi Khanaungto Bridge to be built across the Twantay Canal and the work plan to be carried out in the future.

The Union Minister instructed the necessary processes.

Afterwards, the Union minister and party arrived at the Twantay-Dala road section operated by the Department of Highways.

Deputy Director-General of the Department of Urban and Housing Development of Yangon Region U Myint Naing explained

the development situation of Dala.

Next, Yangon Region Highways Department Director U Htin Kyaw explained the quality control work being carried out and the upgrading of roads in the southern district into 24-foot-wide concrete roads in each financial year. The Union minister also inspected the work on paving the 24 feet wide Twantay-Dala road.

Next, the chief engineer and officials from the Bridge Maintenance Task Force explained the maintenance works of the Twantay Cable-Stayed Bridge and Pun Hlaing Bridge.

The Union minister instructed the responsible persons to cooperate with the Yangon Region Government for regular and systematic inspections of the bridges for long-term sustainability. — MNA



# National-Level Social Security Board Meeting (1/2021) held online

THE Social Security Board of the Ministry of Labour held the National-Level Social Security Board Meeting (1/2021) via videoconferencing in Nay Pyi Taw yesterday.

Union Minister for Labour U Myint Kyaing, in his capacity as the Chairman of the National-Level Social Security Board, Deputy Minister U Win Shein, the Director-General and officials of the Social Security Board, representatives of the board, employers and employees joined the meeting online.

During the meeting, the Union minister said the Social Security Board is working hard together with the international organizations for four types of reforms such as IT Reform, Medical Reform, Administrative Reform and Legal Reform.

He also talked about the preparations to offer medical treatment for COVID-19 positive patients at the workers' hospitals in Yangon, Mandalay and Htantabin, COVID-19 tests of PUI patients during the out-

break of pandemic and transfer of patients to the hospitals authorized by the Ministry of Health.

He then highlighted the 40 per cent of social security fees granted during the first wave of COVID-19 – K21,627.090 million for 857,757 workers of 9,017 factories and industries, while K48,713.995 million for 768,684 workers of 9,116 factories and industries in the second wave, and other plans to provide the social security fees to the remaining workers.

Moreover, it also granted K828.551 million as 40 per cent of the salaries of 14,494 employees who were unemployed from 22 factories burned by arson attacks between 14 March and 30 September.

The officials also vaccinated the workers who registered the social security against COVID-19 and out of 882,595 workers, 548,867 workers have received first jabs and 333,728 have fully inoculated as of 18 November in Yangon, Mandalay, Ayeyawady



and Bago regions.

Then, the Director-General of the Social Security Board reported on the completion of works based on the decisions made at the previous 1/2020 meeting, future work plans and proposals and other attendees coordinated the discussion.

Moreover, the representatives of employers, the Chairman of the Myanmar Garment Entrepreneurs Association, the general secretary of AFFM-IUF and the Chairman of MSC clarified the respective matters and the Director-General of the Social Security Board made de-

isions regarding eight points and 49 proposals at the meeting with the approval of the Union minister.

Finally, the Union minister urged the department concerned, employees and employers, to work together in the future. — MNA

# 25 hospitals, clinics destroyed in bomb, arson attacks of terrorists

AS the government is gearing up the tasks to recover the administration, health, education and other sectors in addition to the economic sector hampered by the COVID-19 pandemic, health staff as good service personnel are actively participating in the prevention, control and treatment activities of COVID-19 and healthcare services for the people dutifully.

Terrorist groups, namely CRPH, NUG and PDF, do not wish to see harmonious cooperation among the government, the Tatmadaw, health staff and the people for uplifting the health sector; brutally killed health staff serving the State duties without any reasons and conduct bomb and arson attacks on the hospitals and clinics. # Phyo Zeyar Thaw's weapons/ammunition support to commit terrorist acts in Yangon recovered

A press release was issued on 20 November regarding the arrest of 50 terrorists, including NLD member Maung Kyaw (a) Phyo Zeyar Thaw who committed acts of violence in Yangon Region under the guidance of NUG terrorist organization. Security forces found and confiscated various types of firearms, homemade bombs, grenades, rounds of ammunition, stimulant tablets, explosive materials and related equipment used in violence during the arrest of the terrorists.

Defendant Maung Kyaw (a) Phyo Zeyar Thaw was born on 26 March 1981 in Yangon. He got his bachelor degree in English from Yadanabon University in 2003 and worked as an artist (singer). He was sentenced to six years in prison for forming an illegal association and holding illegal money but was released on government pardon in 2011. He joined the NLD party in 2012 and in the by-election, he contested as the Pyithu Hluttaw representative for Zabuthiri Township from the NLD and won. He served as a confidant of Daw Aung San Suu Kyi and was closely involved in her domestic and international travels and in campaign.

He did not contest as a Hluttaw representative in the 2020 General Election and he has been leading violent protests in Yangon since February 2021. Since April, he has connected with Yi Mon, Zaw Wai Soe, Lwin Ko Latt from the NUG and acted as the in-charge of Yangon Region. He established Special Task Force-STF and People Defence Force-PDF and carried out terrorist acts.

According to his statement, he issued weapons and ammunition to the assassins based on the mission report on the acts of violence to be carried out in public areas, administration buildings, commerce and school buildings in order to intimidate the public, civil service personnel, township/ward/village administrators. According to his statement, there were 15 cases of killings with the use of weapons and ammunition issued by him.

- A pistol was issued to Ko Gyi, a member of STF to kill U Myo Lwin on 18 May 2021. U Myo Lwin, the ward administrator of the ward (3), Lanmadaw Township, was shot to his head by a group of people while he was on the way to inspect two homemade bomb explosions that happed at the ward administration office.
- On 19 May, two pistols were issued to Lin Paing, a member of STF, to attack the

Sangyoung Township Administration Office. On 21 May, two terrorists attacked the office with firearms and grenades and some members of the security forces were wounded.

- One pistol was issued to Kyaw Thiha, a PDF member, to kill one innocent civilian in Thakayta Township on 19 May. Two men shot an innocent civilian in front of his home at No 23, (20)<sup>th</sup> Manpyay road, 3 Manpyay ward, Thakayta Township.

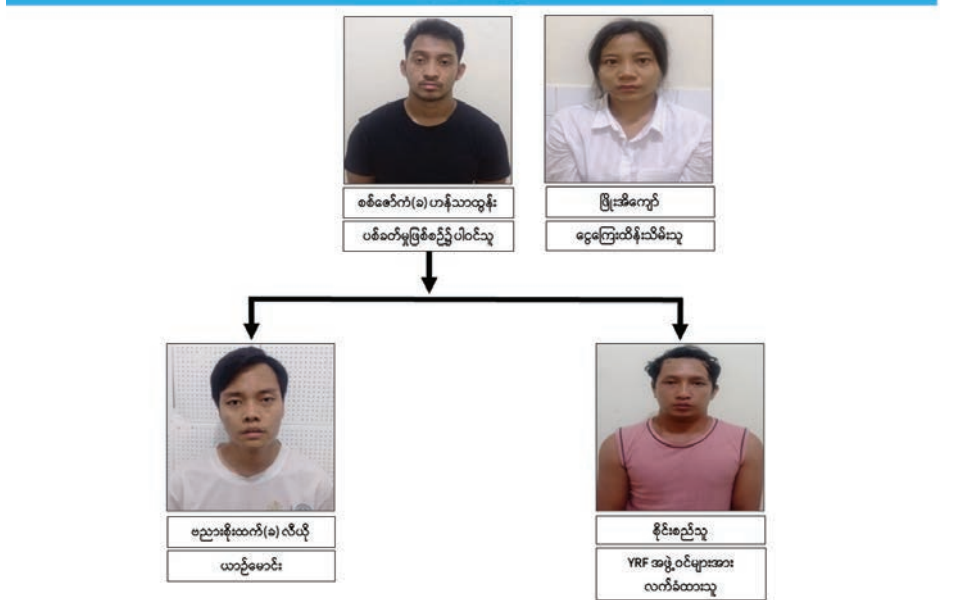


- On 23 October, four pistols were issued to two STF members to attack traffic control police near the Botahtaung market road. Some of the security forces were wounded when four terrorists attacked with small firearms.
- In the third week of October, 2 M-79 bomb launchers and 7 grenades were issued to UG member 44-ST. On 27 October, terrorists attacked the Dawbon police station and Hline police station on 31 October with the launcher. Due to the cooperation of the security forces and dutiful citizens, 39 terrorists (34 men and 5 women) were arrested with 21 small firearms, 50 magazines, 1,465 rounds of ammunition, 12 40-MM bombs, 4 grenades, 32 homemade bombs, 5 smoke bombs, 4 mines, 7 bags of gunpowder, 1 binoculars and 1 drone. # Arrange public transport services for convenient trips of people

**M**YANMAR needs proper public transport services under a systematic management board for the people across the nation with relevant missions and visions for building a prosperous society.

The government enacted laws related to transportation such as the Motor Vehicles Law, the Board of Inland Water Transport Law and the Myanmar National Airlines Law for providing systematic public transport services to the people.

The transport service comprises road transport, rail transport, waterway transport, maritime transport, aviation transport and others. All these services emphasize the transport of passengers from one place to another by cutting the time. From the ancient eras to date, various kinds of vehicles such as bull-oak-cart, pony cart, small boat, sampan and steamed locomotive were used in transport.

The government promulgated the laws related to transportation for ensuring the convenience of public travellers and traffic safety. In fact, public transport plays a key role in the improvement of economic, education, health, social and culture affairs, and swift flow of commodity.

Moreover, the customer first is crucial in public transport. The whole service must give satisfaction to the passengers. Likewise, operators from the bus lines, vessels, trains and aeroplanes would become the prioritized employees. Emphasis must be placed on building the capacity of drivers to have the qualified skills to associate with the passengers on a daily basis. Skilful drivers never focus on their interests but the passengers.

As such, both government and people should harmoniously participate in the implementation of safe public transport services through comprehensive plans for upgrading the living standard of the people.



# What is the "Hit List" of Terrorist Group NUG and its Actual Intention?

**T**HE heated issue on social media in recent days is the reports about the "hit list" of people to be violently killed by the terrorist group NUG. The reports also stated that PDFs are being overseen by the direct instructions of the so-called Minister for Home Affairs of the NUG to kill the people on the "hit list". The letter described the facts: the path of NUG is against the values and norms internationally upheld; the NUG/PDF killed 188 innocent civilians in October alone; the NUG/PDF has killed over 600 unarmed civilians so far; the international communities have the both moral and political authority to put an end to the NUG/PDF becoming the monster; the "hit list" for assassination includes busi-

Latt (fugitive) from NUG, oversees the hit operations. It also found that the peace activist asked for help from international diplomats by attaching a recent picture of NUG/PDF Lwin Ko Latt's online meeting with over 60 PDF groups.

Although the terrorist group NUG is convincingly lying about the "hit list" case, as the case is true and prevailing in the political and diplomatic arena, international communities engaging with NUG start to notice their acts of terrorism they could no longer cover up. Therefore, in the UN Security Council's press statement on Myanmar released on 10 November, members of the Council called for an immediate cessation of violence and to en-

"hit list" case.

The reports of NUG's "hit list" is prevailing on online media and in reality, the people in their daily life are also witnessing the acts of terrorism committed by the NUG/PDFs physically and mentally. Everybody knows the PDF born by the NUG and extreme supporters of the NLD party, on a daily basis, are committing the killings of innocent civilians and Buddhist monks accused of "informant/ dalan"; murders of ward/ village administrators for no reason; mass killings against teachers and education staff and their whole families; bombing attacks against the civilian targets and schools; terrorizing the COVID-19 precautionary measures and vaccination sites; and burn-

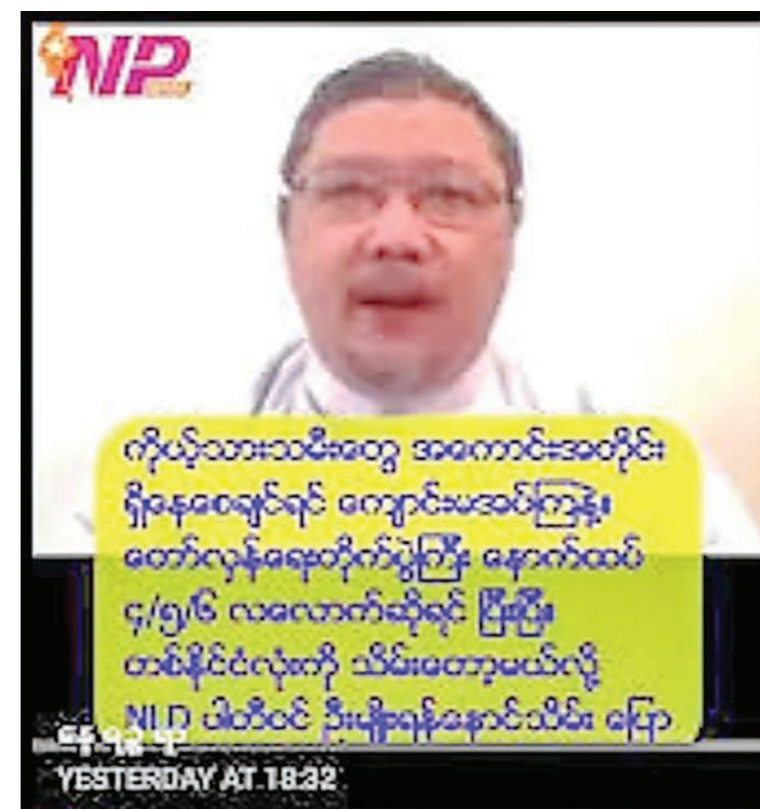
ing down the public houses. The worst thing is killing Buddhist monks and teachers who are the members of Five Infinite Venerables in Myanmar where the majority of societies are Buddhism. Such atrocities are acts of terrorism which are totally unacceptable from the Buddhist perspectives of lawki and lawkuttaya (secular world and the way to escape from worldly desires and attachments). From 3 May to 15 November 2021, 12 Buddhist monks were killed and five were severely injured. Such killings of Buddhist monks in Myanmar regarded as the most religious Theravada Buddhism country by the world countries are serious hazards to Buddha Sasana and also the sorrowful catastrophes for every devotee of Buddhism.

Other grievous events are the violent attacks against the national education sector. By the arrangements of the NUG, the terrorists dehumanize the education staff under the name of Social Punishment to join CDM. When the schools reopened, they recklessly conducted bombing and arson attacks on schools to prevent the children from education. They also brutally killed innocent teachers who did not join CDM. From 1 February to 15 November 2021, there were 438 arson attacks on schools across the country. Moreover, 7 teachers and 5 education staff were violently killed and 13 teachers and 2 education staff were injured making a total of 27.

In any country, every parent of any race wants their children to be educated. The terrorist acts of NUG/PDFs intending to make unable the children to

go to schools is simply breaking down the hopes of parents. Terrorizing the education sector is simply destroying the future of the country. There is much irrefutable evidence showing that those who order to destroy the future of the country are fugitive NUG groups and the implementers are the extremists of NLD party members and PDF terrorists. Brutal killings of Buddhist monks and teachers who are the members of 'Five Infinite Venerables' in Myanmar societies and faiths vividly show that the NUG/PDFs and NLD supporters are inhumane terrorists. Murdering Buddhist monks and teachers for no reason is very despicable and ugly and also the terrorist acts of political extremism which is totally unacceptable both for

Myanmar society and the world.

Moreover, there are further acts of terrorism by NUG/PDF attempting to commit massacres like Al-Qaeda and ISIS. On 12 August 2021, terrorists attempted to crash three ATR-72-600 aircraft with flight numbers (XY-AMP), (XY-AMN), (XY-AMO) of the domestic airline of AIR KBZ by putting leaves into the pilot tubes of the aircraft. Since the responsible persons conducted the inspection and managed to prevent the disaster in time, passengers on board were safe from the mass killing. Similarly, PDF terrorists exploded and burnt down a YBS-20 passenger bus near the Simmalite bus stop in the Kyimyindine township of the Yangon region on 1 October 2021. The passengers were fortunately evacuated in time.

Furthermore, there is much evidence of acts by some fugitives from NUG and NLD hard-core lobbyists confirming the terrorist group NUG is upholding terrorism both physically and mentally. Sasa from terrorist group NUG remarked encouragement at an online terrorist bomb-making class organized by an American in February 2021. An independent online media outlet New Naratif explicitly revealed that the on-line class taught the attendees how to make guns, and bombs, terrorist bombing and extremist ideologies.

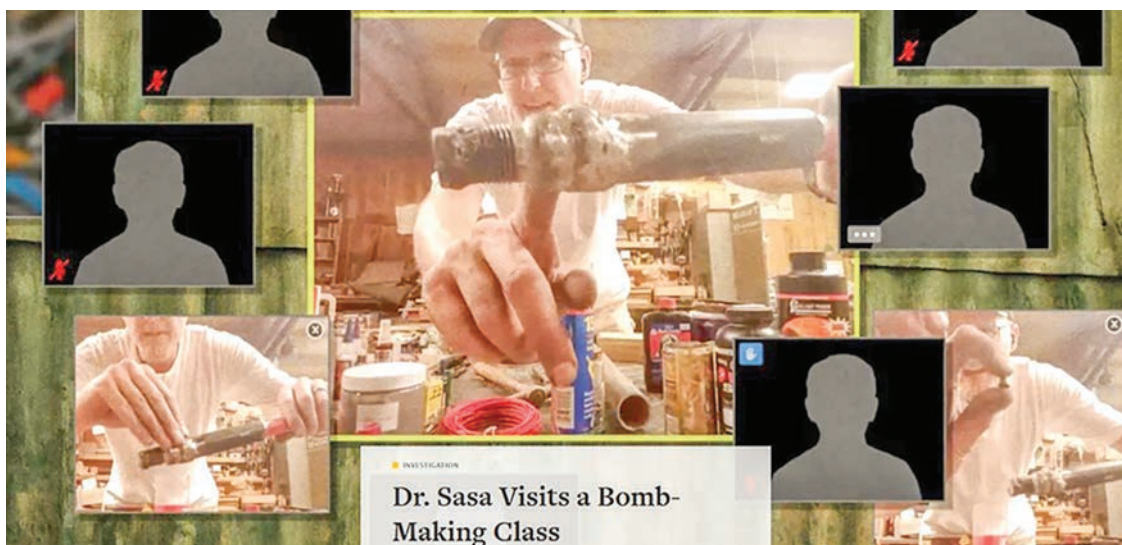

## Myanmar corn exported via sea route

MYANMAR corn is exported abroad via sea route, said U Min Khaing, chairman of the Myanmar Corn Industrial Association (MCIA).

In the previous years, Myanmar corn is exported through both border and sea routes. However, Myanmar is conveying the corn to the Philippines, India, Viet Nam, Laos and Singapore through sea route due to the closure of land borders.

Besides, the corn prices are still high compared to the previous years, U Min Khaing said.

“Currently, the price of corn continues to rise. It can

also be said that the price of the corn this year is higher than the last year,” he added.

At present, the price of corn in the domestic market fetched a good price of around K680 per viss while the FOB exported corn is priced at around US\$259 per tonne.

In the 2020-2021FY, Myanmar exported around 2.3 million tonnes of corn to foreign countries, according to the association.

Of 2.3 million tonnes, Thailand is the largest importing country of Myanmar corn, whereas the remaining numbers of the corn were conveyed

to China, India and Viet Nam. Myanmar is allowed for corn export to Thailand between 1 February and 31 August with Form-D, under zero tariff. Thailand imposed a maximum tax rate of 73 per cent on corn import to protect the rights of their growers if the corn is imported during the corn season of Thailand.

Myanmar exported 2.2 million tonnes of corn to the external market in the past financial year 2019-2020, with an estimated value of \$360 million, the Ministry of Commerce’s data showed.

At present, corn is culti-



At present, corn is cultivated in Shan, Kachin, Kayah and Kayin states and Mandalay, Sagaing and Magway regions. Myanmar has three corn seasons - winter, summer and monsoon.

## China heads top-ten counties exported by Myanmar in 2020-21FY

CHINA topped the list of the ten Myanmar's exported counties with US\$4.9 billion, followed by Thailand with \$3.17 billion in the 2020-2021 financial year (FY), according to the Ministry of Commerce.

The country also exported goods worth \$944.21 million to Japan, \$836.37 million to India, \$620.59 million to the United States, \$426.25 million to Germany, \$411.71 million to Spain, \$385.40 million to the United Kingdom, \$366.18 million to the Netherlands and \$305.76 million to South Korea, the Ministry's figures said.

and over \$6.7 billion worth for imports, according to the data released by the Ministry.

In the same period of the 2019-2020FY, the value of border trade between Myanmar and India totalled over \$1.3

billion, down over \$130 million compared with the same period last year. The Myanmar-India total border trade during the period was shared by Myanmar's export of \$616.46 million and its import of \$696.94

million.

Bilateral border trade between Myanmar and Thailand stood over \$5.1 billion in the FY2019-2020, which saw a decrease of over \$350 million from the corresponding period

of last year.

The country's export to neighbouring Thailand reached \$3.09 billion while its import shared \$2.01 billion.

Agro-based food production, textile and clothing, industry and electronics, fishery production, forestry production, digital production and services, logistics services, quality management, trade information services and innovation and entrepreneurship sectors are the main priority areas of the National Export Strategy (NES) 2020-2021.

NES programme was launched in 2015 and includes textiles and garments, forestry products, beans, pulses and oilseeds, rice, fishery, rubber and tourism sectors. — ZYA/GNLM

## Myanmar pharmaceutical imports surpass US\$590 mln in FY2020-2021



The import value of Myanmar pharmaceutical products was estimated at US\$594 million in the financial year 2020-2021, according to the Myanmar Customs Department.

THE import value of Myanmar pharmaceutical products was estimated at US\$590 million in the financial year 2020-2021, according to the Myanmar Customs Department.

Myanmar imports 90 per cent of medicine and medical products through foreign markets, the Myanmar Chamber of Commerce for Pharmaceuticals & Medical Devices (MCCPMD) stated.

India is the main supplier for Myanmar. Also, it is imported by Bangladesh, China, Germa-

ny, Indonesia, Japan, the Republic of Korea, Malaysia, the Philippines, Singapore, China (Taipei), Thailand, the US and Viet Nam.

At present, pharmaceutical import is regularly flowing. However, the prices of pharmaceuticals were up by 5 to 10 per cent owing to the Kyat depreciation in the local forex market.

The MCCPMD declared the price and product list of the authorized importer companies on its official Facebook page, intending to offer a fair price and

eradicate the substandard, falsified and unregistered medicines in the market.

The Trade Department granted a temporary import licence exemption for 92 HS code lines up to three months starting from 1 September, in a bid to facilitate the trade during the COVID-19 crisis.

The Ministry of Commerce also cut the red tape for imports of some pharmaceuticals which have been imported.

The Union of Myanmar Federation of Chambers of Commerce and Industry (UMFCCI) accelerated its effort to facilitate the inflow of essential medicines in the devastating time of the COVID-19 crisis, along with the related committees, departments concerned, traders and entrepreneurs. The federation formed a task force on 25 July 2021, with an aim to ensure adequate stock of essential medicine for prevention, control and treatment of the COVID-19 and have a smooth trade flow as well. — KK/GNLM

## Myanmar-China Kyinsankyawt border post to resume operations on 25 Nov

KYINSANKYAWT border post between Myanmar and China will be reopened commencing from 25 November, said U Min Thein, vice-chair of the Muse rice depot.

On 22 November, the border crossing will resume on a trial run starting from 1 pm in the afternoon for three days.

"If the trial run of the border post is successfully completed, the border checkpoint will resume its operation on 25 Nov as it is set to be," U Min Thein elaborated.

About 10,000 trucks load of goods, which have been stockpiled in the respective warehouses in Muse 105 mile, will be delivered first, he continued.

China has closed down the remaining land borders (Kyinsankyawt, Wamting) from 8 July 2021 following the COVID-19 cases in Myanmar.

On 30 March, Mang Wein, which is a major border crossing between Muse and Kyalgaung areas, was suspended owing to the COVID-19 cases. On 1 April, Nantaw and Sinphyu border checkpoints were suspended

operations. As a result of this, the border trade between Myanmar and China was completely halted.

The closure of the Sino-Myanmar border trade resulted in job loss of about 400,000-600,000 workers engaged in the Muse land border. Furthermore, the short-haul trucks from Muse to China were also affected by this consequence. Additionally, traders from the Muse border post were also battered by trade suspension, causing a revenue loss.

Myanmar exports agricultural products, including rice, beans and corns, and fishery products such as crab, prawn, etc. Furthermore, Myanmar's natural gas export to China is also conducted through the Muse-Ruili border. The raw CMP materials, electrical appliances and consumer goods are imported into the country.

The land borders next to the Muse border are Nantaw, Sinphyu, Mang Wein, Kyinsankyawt-Wamting and Panseng-Wamting. — NN/GNLM

# Australia to reopen to travellers from Japan, foreign visa holders

AUSTRALIA will allow eligible foreign visa holders and travellers from Japan and South Korea to enter the country from December, Prime Minister Scott Morrison said Monday.

Australia has largely restricted foreigners from entry since March 2020 in a bid to curb the spread of the coronavirus. But on Sunday the country hit 85 per cent of its population aged 16 and over having received two doses of a COVID-19 vaccine.

"The return of skilled workers and students to Australia is a major milestone in our pathway back," Morrison told reporters in Canberra, as the government looks to cement the nation's economic recovery from the pandemic.

From 1 December, fully vaccinated students,

skilled workers and working holiday visa holders will not need to apply for an exemption to its international travel ban.

Vaccinated tourists from Japan and South Korea will also be welcomed back, as well as those on humanitarian visas and provisional family visa holders.

Entry into the states of New South Wales, Victoria and the Australian Capital Territory will be quarantine-free once the restrictions ease next week. However, travellers may still face a mandatory quarantine period in other states and territories with lower vaccination rates.

To take advantage of the changed rules, travellers will need to provide proof of vaccination and to return a negative PCR test 72 hours or less before

departing for Australia.

The government expects 200,000 international students and skilled workers to enter the country by January, Morrison said.

"We will be actively looking to bring as many people into Australia as soon as we possibly can," Minister for Home Affairs Karen Andrews told reporters.

Australia first reopened its borders on 1 November to citizens and permanent residents, allowing them to return quarantine-free after some 20 months of strict border controls.

As vaccination rates increase, the nation has continued to ease border restrictions further, allowing the start of a travel bubble between Australia and Singapore on Sunday. — Kyodo ■

## Pandemic has damaged 'fabric of society': Red Cross

BEYOND killing millions and ravaging economies and health systems, the coronavirus pandemic has taken a devastating socioeconomic toll with women and migrants among the most affected, the Red Cross said Monday.

The International Federation of Red Cross and Red Crescent Societies warned in a new report that the secondary effects of the crisis had disproportionately impacted already vulnerable groups.

The pandemic has pushed many out of work, leading to widespread income loss, it said, pointing to data gathered by its 192 national societies.

The crisis also increased food insecurities, cut access to

education and to protections against violence while exacerbating mental health issues, said the report entitled "Drowning just below the surface".

"Our research shows what we have long suspected and feared, namely that the destructive secondary impacts of this pandemic have damaged the fabric of our society and will be felt for years, if not decades, to come," said IFRC President Francesco Rocca.

'Further towards the edge' The report paints a bleak picture of "people who were already vulnerable, due to conflict, climate change, and poverty, have been pushed further towards the edge," he told reporters.

Around the world, the report

found that women had been particularly hard-hit.

They were more likely than men to have lost work, partly as they more often work in the informal economy and in sectors heavily impacted by restrictions like tourism.

The report also highlighted how lockdowns had created greater social isolation, leaving more women exposed to domestic violence.

Almost all national societies said they had seen a need to increase protection services for victims of sexual and gender-based violence, the report said.

It pointed for instance to the Philippines, where the UN estimated 114,000 additional women

experienced physical and sexual violence in 2020 due to quarantine measures.

Migrants, refugees and people displaced within their countries, who already figured among the world's most vulnerable people, were also among those disproportionately impacted, it said.

A survey of the national societies showed that having a migrant background was the second biggest vulnerability in terms of socioeconomic impacts of the pandemic after homelessness.

The main impact was on employment, with 80 per cent of Syrian refugee households surveyed in Turkey saying at least one family member had lost their job. — AFP ■

## Germans will be 'vaccinated, cured or dead': minister

MOST Germans will be "vaccinated, cured or dead" from Covid-19 in a few months, Health Minister Jens Spahn warned Monday as he urged more citizens to

get jabbed.

"Probably by the end of this winter, as is sometimes cynically said, pretty much everyone in Germany will be vaccinated, cured or dead," Spahn said, blaming "the very contagious Delta variant".

"That is why we so urgently recommend vaccination," he added.

The stark warning comes as Germany is racing to contain a record rise in coronavirus infections in recent weeks, with hospitals sounding the alarm about overflowing intensive care units.

Despite widespread access to free coronavirus vaccines, just 68 per cent of the German population is fully vaccinated, a level experts say is too low to keep the pandemic

under control.

Germany, the EU's most populous country, added another 30,643 cases on Monday, according to the Robert Koch Institute health agency, bringing the total since the start of the pandemic to just over 5.3 million.

Almost 100,000 people have died so far, including 62 over the past 24 hours.

"We have a very, very difficult situation in many hospitals," Spahn said. Germany last week announced tougher coronavirus curbs to contain the ferocious fourth Covid wave.

In regions with high hospitalisation rates, the unvaccinated will be barred from public spaces like cinemas, gyms and indoor dining. — AFP ■

## Israel, Jordan agree US-brokered solar power for water deal

JORDAN will provide solar power to Israel, which will in turn supply desalinated water to its desert neighbour, under a declaration of intent the two countries signed Monday.

Ministers from the neighbouring countries inked the US-brokered agreement at a Dubai Expo event joined by John Kerry, the US Special Presidential Envoy for Climate.

"The Middle East is on the frontline of the climate crisis," Kerry said in a statement. "Only by working together can countries in the region rise to the scale of the challenge."

The United Arab Emirates, which last year normalised rela-

tions with Israel, will reportedly build the solar power plant, the value of which was not disclosed.

Israeli Energy Minister Karine Elharrar said the Israel-Jordan agreement was the "most significant" since the former enemies signed a peace treaty in 1994.

"The benefit of this agreement is not only in the form of green electricity or desalinated water, but also the strengthening of relations with the neighbour that has the longest border with Israel."

Feasibility studies for the project are due to start next year.

Jordan is one of the world's

most water-deficient nations and its cooperation on water with Israel dates back to before the two established formal relations.

Israel is also a hot, dry country, but its advanced desalination technology has opened opportunities for selling fresh water. — AFP ■

## NEWS IN BRIEF

### Kenya police launch murder probe into BBC staffer's death

KENYA has launched a murder investigation into the death of a BBC staff member in a Nairobi hotel room, the city's police chief said Monday.

The body of Kate Mitchell, a British national who worked for BBC Media Action, the broadcaster's international charity, was found on Friday, shortly after an emergency alarm was activated in her room, police said. Her eighth-floor room's window was broken and the body of a man she had been with earlier was found on the ground outside the hotel.

"We are investigating circumstances surrounding these deaths, but so far it is apparent the man jumped (out of) the window after killing her," Nairobi police chief Augustine Thumbi told AFP. "We do not know the motive so far, and these are things the investigators are trying to put together." — AFP ■

### Car strikes US Christmas parade, killing 5 and wounding 40

AMERICANS were reeling Monday from an "unthinkable tragedy" after a driver slammed through barricades and into a Christmas parade in the Midwestern city of Waukesha, killing at least five and wounding more than 40.

The Sunday evening chaos which saw a red SUV speed into a crowd of men, women and children, raised immediate fears of a deliberate act — in a state where tensions have spiked following a high-profile acquittal in a racially-charged trial.

But CNN and NBC both cited law enforcement sources as saying there was no known connection to terrorism at this stage — nor to Friday's verdict in the case of Kyle Rittenhouse, a teenager who fatally shot two people during Black Lives Matter protests in nearby Kenosha last year.

Multiple US media quoted investigators as saying there were signs the driver was fleeing another incident at the time. — AFP ■



## JR East launches bullet train “office cars” amid telework demand

EAST Japan Railway Co on Monday launched onboard “office cars” on certain shinkansen bullet trains on lines connecting Tokyo and the country’s northern and central parts to meet growing demand for a new work style amid the coronavirus pandemic.

For no additional charge and only on weekdays, passengers on the No 8 cars on the Tohoku, Joetsu, and Hokuriku lines can now talk on the phone and participate in online meetings from their seats — activities that are discouraged on the rest of the train.

“We want to support a new way of working that is not bound by time and place,” said an official

of the railway operator known as JR East, which finally began the service in earnest after successful trial runs.

Media were granted access inside a running Hokuriku bullet train on Monday, where a sticker saying “office car” had been put on a door of the No 8 car and leaflets explaining the service were placed at the seats.

A JR East staff demonstrated to the media how she works remotely, using a noise-cancelling headphone.

Passengers will also be able to borrow “smart glasses” that project the content of their laptop screens before their eyes. On bullet trains on the Tohoku line,

they will also be able to use free of charge small dividers to put around their seat tables, with a similar measure being considered for the Hokuriku and Joetsu lines.

The remote work spaces onboard the shinkansen are also available on a different railway operator’s shinkansen line in Hokkaido, which connects directly to the Tohoku line.

JR East hopes the new service will help people go on “workation” trips in which they combine working online with travel, while also stimulating demand for business trips, which has decreased due to the COVID-19 pandemic. — Kyodo ■

## US, Britain, Australia sign AUKUS information-sharing agreement

AUSTRALIA on Monday signed an agreement with the United States and Britain formalizing access to classified nuclear submarine information under their so-called AUKUS security partnership.

The Exchange of Naval Nuclear Propulsion Information Agreement is the first embodiment of the three-way arrangement announced in September under which Australia looks to acquire nuclear-powered submarines amid China’s growing maritime power. The agreement will allow the United States and Britain to share their nuclear submarine secrets with a third country for the first time.

“This Agreement will support Australia in completing the 18 months of intensive and comprehensive examination of the requirements underpinning

the delivery of nuclear-powered submarines,” Defence Minister Peter Dutton said in a statement.

The agreement will also provide a mechanism for Australian personnel to access training

and education from their US and British counterparts on how to safely and effectively build, operate and support nuclear-powered submarines, the statement said.

## Japan, India foreign ministers affirm Quad cooperation

THE foreign ministers of Japan and India held phone talks on Monday and affirmed their resolve to work with the other members of the “Quad” — the United States and Australia — to realize a free and open Indo-Pacific region.

The call between Yoshimasa Hayashi and Subrahmanyam Jaishankar came as the group has stepped up cooperation to counter China’s growing military and economic clout.

Hayashi and Jaishankar shared their “strong opposition to unilateral attempts to change the status quo in the East and South China seas and economic coercion,” Japan’s Foreign Ministry said without explicitly naming Beijing. During the roughly 20-minute call, they

agreed on the importance of resuming reciprocal visits by their leaders, including Japanese Prime Minister Fumio Kishida travelling to India at an “appropriate time” and arranging two-plus-two security talks among foreign and defence ministers, the ministry said.

Hayashi, who was appointed by Kishida earlier this month, and Jaishankar also discussed North Korea’s recent missile tests and situations in Myanmar and Afghanistan.

Having held joint military exercises and met at the ministerial level in recent years, the Quad held its first in-person leaders’ summit hosted by US President Joe Biden in Washington in September. — Kyodo ■

## Iran says hopes for ‘constructive’ visit by IAEA chief

IRAN said Monday it hoped a visit by the chief of the UN’s atomic watchdog would be “constructive”, just days ahead of the resumption of talks seeking to revive the 2015 nuclear deal.

Rafael Grossi, head of the International Atomic Energy Agency (IAEA), was to arrive in Tehran later Monday.

He was expected to meet Foreign Minister Hossein Amir-Abdollahian and Atomic Energy Organization chief Mohammad Eslami, who is also one of Iran’s vice-presidents.

“We hope that Rafael Grossi’s

visit will be as constructive as the previous ones,” foreign ministry spokesman Saeed Khatibzadeh told reporters.

“We have always advised the IAEA to stay on the path of technical cooperation, and to not let certain countries pursue their political orientations on behalf of the IAEA,” he added. On Friday, the IAEA said Tehran had again increased its stockpile of highly enriched uranium, many times in excess of the limit laid down in the 2015 agreement.

Grossi’s visit comes as Iran readies for talks with world powers

in Vienna on 29 November on saving Tehran’s 2015 deal with major powers, that promised it sanctions relief in return for curbs on its nuclear programme. “We will leave for Vienna with a full team and a serious will to lift the sanctions,” Khatibzadeh said. “The other parties should also try to come to Vienna to reach a practical and comprehensive agreement.”

The landmark deal was torpedoed in 2018 by then US president Donald Trump’s unilateral decision to withdraw Washington from it and impose a punishing sanctions regime. — AFP ■

## Southgate wants to create 'new memories' after extending England deal

GARETH Southgate said Monday he was excited to sign a two-year contract extension as England manager after an "incredible experience" during his five years at the helm.

The 51-year-old's deal was set to expire after next year's World Cup but he has been rewarded by the Football Association after England reached the Euro 2020 final — their best performance at a major tournament for 55 years. Southgate, who also

masterminded a run to the semi-finals at the 2018 World Cup in Russia, has transformed his team into serious contenders after years of underachievement.

"I'd like to say how excited we are — the last five years have been an incredible experience," said the former Middlesbrough boss, whose side last week sealed qualification for the World Cup in Qatar.

"We can see what's possible with the

existing squad and some of the players coming through our age-group teams. We are grateful for the support of the FA.

"We felt it was important to qualify (before signing) so there was no question on focus. We are looking forward to the next few years to make some new memories." Southgate, who will now oversee England's Euro 2024 campaign, told reporters his side had made great progress.

"To see Ole unfortunately lose his job yesterday was tough for me and tough for a lot of people at the club," said Carrick, who won a clutch of major trophies as a United player between 2006 and 2018.
